- / **Best VAT/Indirect Tax Team** demonstrated our excellence in VAT, a highly specialist and complex area.


These shortlistings followed our success at the 2022 Taxation Awards, when Sam Inkersole won the Taxation's Rising Star award.

On 26 April, Lee Brook was a keynote speaker at The Alternative Accountancy Management Summit in Marlow. The agenda focused on helping leaders develop and take action around purpose within their firms, grow their leadership skills and attract and retain talented people.

Lee was part of the Managing Partner Show & Tell on Day One, discussing the challenges and opportunities facing the firm and the profession. Lee's talk was titled *Moving IT from a cost to a profit centre*.

Later in Day One, Lee chaired a roundtable titled *Purpose: what's the point?* This explored the intersection of purpose and culture and how this impacts recruitment and retention strategies. With 26 April being Better Business Day, organised by the Better Business Act (see page 15), the timing was ideal.

In the afternoon, Duncan led a roundtable discussion on what Power Query, Power Automate and Power BI can do for accountancy practices. The following day, Duncan spoke about making digital sustainable: creating a balance between user experience, business goals, and environmental initiatives.







Business, but better



Since becoming a Certified B Corporation (B Corp) last year, we're continuing to build a sustainable business: one that operates as a force for good.

B Corps are a worldwide community of businesses that meet high standards of verified social and environmental performance, public transparency and legal accountability to balance profit and purpose.

B Lab, a US-based not-for-profit network, provides this certification. The B stands for *Benefit for all*.

March was B Corp Month: a time for B Corps to take pride and raise awareness. we had a taste (literally) of how lovely the B Corp UK community is.

Putting on a lunchtime session for everyone at BKL to learn more about B Corp certification from our Head of ESG Myfanwy Neville, we decided that the ideal accompaniment would be a table of refreshments from our fellow B Corps. We got in touch with several to ask if they'd be willing to send us some snacks and drinks... and our pictures show how generous they were! Our thanks to The Curators, PROPER Snacks, graze, Karma Drinks, Candy Kittens, innocent drinks, Kallo and Tony's Chocolonely.

We're proud that Myfanwy has been accepted onto the ICAEW Sustainability Committee. Myfanwy represents not just BKL but the growing number of ICAEW member firms who are also part of the B Corp community.

Carbon neutral

As a business, we're also proud to have become carbon neutral. To achieve this, we first calculated our 2019-2022



greenhouse gas emissions for Scope 1 and Scope 2, and combining this with an estimate of our Scope 3 emissions.

- / Scope I covers emissions from sources we own
- / Scope 2 covers generation of purchased electricity that is consumed in our own environment.
- / Scope 3 is the broadest category and covers indirect emissions, such as those from suppliers and transport.

Next, we invested in two gold standard accredited carbon offset projects. One provides clean energy cooking-stoves to families in Nigeria; the other builds wind farms in China. Our next steps will be to get a better calculation of our Scope 3 emissions and to design a net zero plan using science-based targets.

Better Business Act

We've joined the Better Business Act coalition alongside more than 2,000 other UK businesses.

According to B Lab's research, 78% agreed that 'the law should change to ensure businesses have a responsibility to look after people and the planet alongside making a profit'. The Better Business Act is a campaign to change the UK law so that every company in the UK acts in the interests of wider society and the environment.

Like all B Corps in the UK, we have already amended our articles of association to, in B Lab's words, 'formally embed consideration of all stakeholders ... driving greater accountability'.

In the press

To help others who may just be starting or contemplating their own B Corp or ESG (environmental, social and governance) journey, we've enjoyed sharing our experience alongside other businesses'. Most recently, this has included contributing to an ICAEW Insights article on what it means to become a B Corp; and writing a Taxation magazine article that brought together four accountancy firms' experience of B Corp Certification. Both articles are available via our website.



To ensure we can keep making a positive difference, our impact forum Mosaic has expanded; BKL's charitable foundation has grown too; and we were pleased to welcome our first Impact Project Manager, Rebecca Jackson. As a transparent way to express BKL's purpose, progress and plans, we're currently putting together our first impact report. We look forward to sharing this later in 2023.

Our Head of Payroll, Gary Silver, has led our specialist team for 14 years. The team has grown in recent years and now has seven people. It is one of BKL's majority-female teams. It also supports learning and



development, with three members of the team currently completing professional qualifications.

UPDATES

Tax Administration and Maintenance Day 2023

27 April saw the Government's announcement of a package of tax policy proposals on the second Tax Administration and Maintenance Day. The main targets of the proposals were the simplification and modernisation of the tax system and tackling the tax gap, together with a number of more general proposals.

Announcements and proposals included:

Simplification and modernisation of the tax system

- / Consultation on the treatment of post and parcel exports
- / Further consultation on the potential amendment to the tax treatment of cryptoasset decentralised Finance (DeFi) lending and staking. This is a specialist area for our Tax Senior Manager Sam Inkersole, whose latest article on HMRC's current crypto and DeFi guidance is available here
- / Consultation on the modernisation of the Stamp Taxes on Shares framework
- / Consultations to be published this month in relation to diverted profits tax, transfer pricing and the taxing of UK permanent establishments

Tackling the tax gap

- / Consultation on the possible introduction of a new criminal offence for non-compliant promoters of tax avoidance
- / Guidance on the registration of repayment agents in a three-month window from 2 May

- / Consultation on Construction Industry Scheme (CIS) reform
- / Consultation on employee ownership trusts

Other matters

- / Consultation on a potential change to the off-payroll working legislation to counter over-collection of tax
- / Consultation to be published later this year in relation to the plastic packaging tax (PPT)

Charities Act 2022

The Charity Commission, along with the Department for Culture, Media and Sport, is pushing ahead with its implementation plan of the Charities Act 2022 that was given royal assent back in February 2022. The introduced changes are the penultimate part of the Commission's plan to roll out all parts of the new act by the end of 2023.

The main changes are split into three sections:

Selling, leasing or otherwise disposing of charity land

These changes are intended to simplify and clarify some of the legal requirements of charities and their trustees. Key changes to this section are:

- / Widening the category of designated advisers who can provide charities with advice on certain disposals. Previously limited to RICS qualified surveyors, this now includes Fellows of the National Association of Estate Agents, Fellows of the Central Association of Agricultural Valuers and any suitably qualified trustee, charity officer or employee.
- / Giving trustees discretion to decide how to advertise a proposed disposal of charity land. A charity is now

- only required to consider the need to advertise a proposed disposal based on advice given by the charity's adviser.
- / Removing the requirement for charities to get Commission authority to grant a residential lease to a charity employee for a short periodic or fixed term tenancy.

There are further provisions for this section, due to be implemented later in 2023, relating to liquidators and those items included in statements and certificates for both disposals and mortgages.

Using permanent endowment

These changes focus on providing new statutory powers to charities to make use of small amounts of permanent endowment under its care. These new powers enable charities to:

- / Spend, in certain circumstances, from a 'smaller value' permanent endowment fund of £25,000 or less without Commission authority. Before these new powers, charities had to apply to the Commission for authority to use even the smallest of endowment funds.
- / Borrow up to 25% of the value of their permanent endowment fund without Commission authority. This only applies to certain charities.
- / Use permanent endowment to make social investments with a negative or uncertain financial return, provided any losses are offset by other gains. This power is only available to those charities opted into the total return approach to investments.

If any charity is unable to use statutory powers then Commission authority must still be sought in all instances.

Charity names

These changes increase the Commission's powers in relation to official, working or trading names of charities. Current powers allow the Commission to direct a charity to change its name if it is too similar to another charity's name or is offensive or misleading. New powers will allow the Commission to:

- / Direct a charity to stop using a working name if it is too similar to another charity's name or is offensive or misleading. A working name is any name used to identify a charity and under which the activities of the charity are carried out. For example, 'Comic Relief' is the working name of the charity 'Charity Projects'.
- / Delay registration of a charity with an unsuitable name or delay entry of a new unsuitable name onto the Register of Charities.
- Use its powers in relation to exempt charities in consultation with the principal regulator (i.e.
 Companies House, Financial Conduct Authority).

Further changes ahead

The last set of changes will be brought into force later in 2023 and will include provisions on:

- / Charity constitutions
- / Charity land
- / Powers relating to appointments of trustees
- / Remuneration of charity trustees
- / Charity mergers
- / An amendment of the Universities and College Estates Act 1925

We look forward to providing more details once these final changes come into effect.
